AGREEMENT OF: WAIVER, CONSENT AND RELEASE

Waiver, Consent and Release: In consideration of being allowed to participate in the activities of the SNAKE MEADOW CLUB, I hereby waive any right of recovery for any injury incurred by myself and my child or children, (if accompanied by a child or children), and to my property during any activity, special event, or any other club sponsored function, be it fish, hunting, shooting, archery, 3D Archery, hiking, picnics or visiting the Snake Meadow Club, Inc, whether self-inflicted or inflicted by others and whether or not the acts of others were intentional or negligent. In no case shall I hold any of the Snake Meadow Club, Inc officers, board members or other club members responsible for the acts of third persons who may injure myself, my child or children on this property. I execute this waiver, consent and release on my own behalf and on behalf of my child or children, if they are accompanying me, realizing that this sport is not hazard-free and fully assuming those risks of all conditions in and about the activity area. I also waive any and all specific notice of the existence of any hazards.

I acknowledge that utilizing the Snake Meadow Club facilities has inherent risks, hazards, and dangers for anyone, which cannot be eliminated, particularly in a wilderness environment. I UNDERSTAND THAT THESE RISKS, HAZARDS, AND DANGERS INCLUDE WITHOUT LIMITATION:

1. The risk of handling firearms and being near others that have firearms in their possession;
2. The risk of injury from ammunition and shot from other guns;
3. Walking in rugged country, including encounters with wildlife, animals and insects;
4. Inclement weather conditions;
5. The risk of injury from riding on an all-terrain vehicle (ATV) or any vehicle used off the paved road.
6. The risk of injury from the use of tree stands.
7. Un-motorized water crafts as well as fishing docks and platforms.

I understand that these activities may require good physical conditioning and a degree of skill and knowledge. I believe I have that good physical conditioning and the degree of skill and knowledge necessary for me to engage in these activities safely. I understand that I have responsibilities. My participation in this activity is purely voluntary. No one is forcing me to participate and I elect to participate in spite of the risks.

I AM VOLUNTARILY USING THE SERVICES OF SNAKE MEADOW CLUB INC, WITH FULL KNOWLEDGE OF THE INHERENT RISKS, HAZARDS, AND DANGERS INVOLVED AND HEREBY ASSUME AND ACCEPT ANY AND ALL RISKS OF INJURY, PARALYSIS, OR DEATH.

I (we) hereby assume the sole responsibility for and indemnify and hold the Snake Meadow Club Inc and all aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting from, or sustained by any person or persons, including myself (ourselves) or on account of damage to property, arising out of or in consequence of my (our) participation in any use of the Snake Meadow Club property however such injuries, death or damage to property may be caused, and whether or not the same may have been caused or may be alleged to have been caused by negligence of the aforementioned parties, any of their employees or agents or any other person.
